# Rules:

- A Manitoba Fishing License is required and all Manitoba regulations apply.
- Boat inspection 6:00 am to 8:00 am.
- Fishing hours: Flight #1 8:00 am to 4:00 pm, Flight #2 8:15 am to 4:15 pm.
- All boats must be equipped with working live wells. Total live release tournament.
- Each team will be allowed to weigh up to 4 fish per day. No more than 4 fish in live well at one time.
- All Sauger, Saugeye, and Walleye are eligible to be weighed in.
- Only 2 walleye over 55cm. in possession at one time.
- Only 2 walleye over 70cm. per boat for weekend. All walleye under 55 cm. count.
- Fish tails will be pinched width of ruler, with mouth closed when measured.
- Any dead or stressed fish brought in will not be counted.
- Boats arriving late will be penalized 1lb per minute up to 5 minutes. Thereafter, day's weight will not be counted.
- No passing of items between boats during fishing hours.
- No fisherman will be allowed to go to shore, except at the fishing dock.
- Boats must stay 10ft apart during fishing hours and 5ft apart around dock.
- Boat inspections may be done during fishing hours
- Children under 18 years of age must be accompanied by an adult.
- All contestants must read and sign liability release form.
- One member from each team is required to attend the rules meeting.
- All contestants must report to dock before leaving water.
- In the event of a tie, day one placement will determine winner.
- Protests must be made immediately after fishing day. \$250 per protest. Committee decision will be final. Money will be refunded if protest is valid.

## Judges decisions will be final

- 50% Payment must be made to have boat number assigned. Confirmation decision will be emailed to all captains.
- No cheques will be accepted after midnight, October 1, 2011.
- Refund will only be given under extreme circumstances.

### PARTICIPATION RELEASE - READ BEFORE SIGNING

In consideration of being allowed to participate in any way in the 2008 Winnipeg River Greenback Championship, The Undersigned, acknowledge, appreciate, and agree that:
